MINUTES OF LAKE TRAVIS COMMUNITY LIBRARY DISTRICT BOARD OF TRUSTEES

January 28, 2016

At 2:00 p.m., President Carol Black called to order the one hundred and ninety-fifth meeting of the Trustees of the Lake Travis Community Library District. The meeting was convened in the Lake Travis Community Library. Board Members present were Alan Gober, PK Chatterjee, Carol Black, Nancy Pencsak and Sharon Rogers. Attendees were Morgan McMillian, Jean Dowdy, Mikus Grinbergs and Diane Taylor.

The Pledge of Allegiance to the Flag of the United States of America and the Flag of the State of Texas were recited.

- 3. Carol Black asked for the approval of the December 17, 2015 minutes. PK Chatterjee made a motion to approve the minutes. Alan Gober seconded the motion. The motion passed unanimously.
- 4. CITIZENS PARTICIPATION: None.
- 5. There was no Art donation to consider.
- 6. Vice-President Sharon Rogers serves as the Board historian. Ms. Rogers has compiled information to be presented at a later date.

- 7. The Board still has great interest in pursuing the Book Mobile option as a start to better serving the outlying areas of the LTCLD.

The Book Mobile has been ordered, and a down payment of 30% has been paid.

Sharon Rogers made a motion to send a library representative to Ohio to make decisions on colors, carpet, and like items. Alan Gober seconded the motion.

- 8. Librarian's Report. Morgan McMillian stated that compared to December 2015, program attendance is up 30%. The door count is up 5%, and circulation is up 3%. OverDrive transactions were up 33%. The library currently has 9,849 active card holder accounts. Wi-Fi statistics are now tracked; there were 2,548 connections in December. The Six Savants & A Prodigy Art Reception will be Sunday, February 7, 2016, from 2:00 to 3:30 p.m. in the meeting room. CITIZENS PARTICIPATION: None.
- 9. Morgan McMillian and Alan Gober have researched the purchase of new library tables that will easily be transported in and out of the closet of the meeting room. Eight tables have been ordered and are scheduled to be delivered the first week of February. The old tables are to be given to the Lake Travis Thrift Store. CITIZENS PARTICIPATION: None.
- 10. Morgan McMillian and Carol Black have been reviewing and updating for approval, or deletion, portions of the LTCLD Policy Manual. Today, they presented for deletion LTCLD Internet Access Policy and Web Links Policy. Alan Gober made a motion to delete the Internet Access Policy and Web Links Policy. Sharon Rogers seconded the motion. CITIZENS PARTICIPATION: None.
