MINUTES OF LAKE TRAVIS COMMUNITY LIBRARY DISTRICT BOARD OF TRUSTEES June 23, 2016

At 2:00 p.m., President Carol Black called to order the two hundredth meeting of the Trustees of the Lake Travis Community Library District. The meeting was convened in the Lake Travis Community Library. Board Members present were Carol Black, PK Chatterjee, Alan Gober, Nancy Pencsak and Sharon Rogers. Attendees were Morgan McMillian, Karen Ballinger, and Mikus Grinbergs.

The Pledge of Allegiance to the Flag of the United States of America and the Flag of the State of Texas were recited.

- 3. To recognize the 200th Board Meeting of the Library District, Carol Black read from the minutes of the first meeting, held on May 27, 2004, and chaired by Friends representative Margaret McDermott. Present at that meeting were Bob Johntz, Dan Pedersen, Nancy Pencsak, Mary Whitaker, Carol Black, Rhonda Hostetler, Margaret McDermott, Mary Shook, Joe Davis, Kirk D. Clennon, Julie Rhone, Bill Rhone, Frank Black, Ray Pencsak, Amanda Black, Brenda Black, and Glenda Foreman, Mayor Pro-Tem of the City of Lakeway. Dr. Black expressed the Board's appreciation of all the efforts to establish the Library District.
- 4. Nancy Pencsak asked for the approval of the May 26, 2016 minutes. Alan Gober made a motion to approve the minutes. Sharon Rogers seconded the motion. The motion passed unanimously.
- 5. CITIZENS PARTICIPATION: None.
- 6. There was no Art donation to consider.
- 7. The Board has great interest in pursuing Outreach Services to better serve the outlying areas of the LTCLD. The Book Mobile has been ordered, with an estimated date of completion, July 28. Plans are for the Book Mobile to start travelling as soon as possible. Karen Ballinger presented library updates to accommodate the bookmobile and a tentative schedule for anticipated stops. CITIZENS PARTICIPATION: None.
- 8, Morgan McMillian presented information on the November 8, 2016 General Election. There are three positions up for election, those now held by Carol Black, PK Chatterjee and Nancy Pencsak. Alan Gober made a motion to call for an election to be held on November 08, 2016. Sharon Rogers seconded the motion.

CITIZENS PARTICIPATION: None. The motion passed unanimously.

9. Librarian's Report. Morgan McMillian stated that compared to May 2016, the door count was unchanged, and circulation is up 8%. Overdrive transactions were up 63%. There were 37% more programs during May. The library currently has 10,157 active card holder accounts. The LTCL website had 2,845 unique visitors. Local artist Alex Retivov's paintings will be on exhibit during the month of July. The Artwork reception will be Sunday, July 10th from 1:30p.m. to 3:00 p.m.

The library won a Sisters in Crime's We Love Libraries grant of \$1,000 and two Texas Commission on the Arts grants for \$325 for Summer Reading Programs.

The next Board meeting will be held in the Teen Room due to Summer Reading Programs in the Meeting Room. The Summer Reading Finale will be Friday, July 29 from 4:00 p.m. to 6:00 p.m.
