MINUTES OF LAKE TRAVIS COMMUNITY LIBRARY DISTRICT BOARD OF TRUSTEES April 25, 2005

At 6:31 p.m., President Nancy Pencsak called the twenty-first meeting of the Trustees of the Lake Travis Community Library District to order. The meeting was convened in the Lake Travis High School/Community Library. Board Members present were Nancy Pencsak, Bob Johntz, Carol Black, and Mary Whitaker. Attendees were Rhonda Hostetler, John Brodnax, Peter Hitt, and Pam Murray.

The Pledge of Allegiance to the Flag of the United States of America and the Flag of the State of Texas were recited.

The first order of business was the approval of the April 11, 2005 minutes. Bob Johntz made a motion to approve the minutes as read. Mary Whitaker seconded the motion. The motion passed.

The next agenda item was the treasurer's report. Because Dan Pedersen was not present, he had sent a written treasurer's report and financial documents. On May 16th, two trustees will be sworn in. The paperwork for this ceremony was discussed. There will be an election of officers. Mary Whitaker will ask Mary Shook to appear as Notary to witness signatures of Trustees.

President, Nancy Penscak adjourned the meeting at 6:58 p.m. to go into Executive Session for two agenda items.
