MINUTES OF LAKE TRAVIS COMMUNITY LIBRARY DISTRICT BOARD OF TRUSTEES July 09, 2007

At 6:31 p.m., President Carol Black called to order the fifty-eighth meeting of the Trustees of the Lake Travis Community Library District. The meeting was convened in the Lake Travis Community Library. Board Members present were Carol Black, Sharon Rogers, Nancy Pencsak, Bob Johntz, and P. K. Chatterjee. Attendees were Sharon Temple, Jean Dowdy, Peter Hitt, and P. A. Penley.

The first order of business was the approval of the June 11, 2007 minutes. Bob Johntz made a motion to approve the minutes. P. K. Chatterjee seconded the motion. The motion passed.

Peter Hitt presented a slide presentation report from the Land Acquisition Committee, outlining cost estimates for a one story library building and for a two story building. Sharon Temple presented the Librarian's Report for June. The Library's holdings now total 23,160 items. The door count for June was 6,222, and there were 12,559 library transactions. The Summer Reading Program Party will be held August 21 in the Lakeway City Park. Citizens participation: None

Bob Johntz led a discussion/review of the Lease Agreement with the Shopping Center. He pointed out that there is an addendum to the lease providing the options of 2 one-year leases.
