## MINUTES OF LAKE TRAVIS COMMUNITY LIBRARY DISTRICT BOARD OF TRUSTEES

May 27, 2021 264th MEETING

- 1. At 3:30 p.m. Carol Black called to order the meeting of the Trustees of the Lake Travis Community Library District. The meeting was convened via video conference. Board Members present were Carol Black, P.K. Chatterjee, Sharon Rogers, Alan Gober and Amy Holland. Morgan McMillian and Nancy Pencsak were also present.
